## COMMITTEE DESCRIPTIONS

Admissions: Sell tickets and/or check credentials of spectators to allow access into the event.

Caddie Registration & Hospitality: Provide caddies with information and equipment. Staff hospitality area.

Communications\*: Coordinate all communications regarding scoring.

Laser Operator\*: Record statistics and scores. Operate lasers. Required Thursday – Sunday commitment.

Marshal: Provide gallery control during the tournament. Committee requires 4 full days of volunteering.

Player Transportation: Prepare, distribute and arrange for return of tournament vehicles. Assist in operating player and media shuttles.

Spectator Transportation: Provide assistance and direction to spectators using tournament shuttle system.

Special Needs Transportation:: Assist in transporting persons with special needs between the parking area and the golf courses.

Uniform Distribution: Organize and distribute uniforms to committees prior to event.

Volunteer Hospitality: Prepare and serve food and beverage to tournament volunteers.

Walking Scorer: Record statistics and scores. Must be able to walk all 18 holes and have golf knowledge. Required Thursday – Sunday commitment.

Note: More detailed descriptions of committees, including physical requirements, are available by calling 831 649-1533.

\* May be required to climb ladders and work on elevated platforms.

## Volunteer acknowledgment, release, waiver and hold harmless agreement:

My signature below indicates my acknowledgment that the Monterey Peninsula Foundation may undertake a check of my background. It also confirms my understanding that my volunteer position is not guaranteed, nor if granted, guaranteed for any length of time, and that the Monterey Peninsula Foundation may deny or end my volunteer opportunity at any time, for any reason, with or without prior notice.

I acknowledge that as a volunteer, insurance benefits, if any, provided by the Monterey Peninsula Foundation are limited in the event I sustain any injuries while volunteering. If injured, I will immediately contact the medical personnel on site, and after the tournament, should there be any additional medical follow-up needed, I will contact the Monterey Peninsula Foundation office for further information concerning this insurance and its benefits.

Pursuant to my participation as a volunteer, I recognize that there are risks and possible injuries that one may sustain through such participation, including, but not limited to the following:

- (i) being struck by a golf club or errant or misdirected golf ball;
- (ii) being struck by a golf cart or other vehicle;
- (iii) falls due to unevenness of terrain or surfaces;
- (iv) injuries arising from sports, physical exertion, or activities;
- (v) injuries arising from lightning, heat, cold, rain or other weather-related factors; and
- (vi) any other injuries or damages I may sustain as a volunteer.

In return for being permitted to participate as a volunteer, I assume all risks associated with my participation in the AT&T Pebble Beach National Pro-Am and agree that I, my assignees, heirs, distributees, guardians, legal representatives, and all those claiming through me, release, waive, hold harmless, and agree not to make a claim against or sue the PGA Tour, Monterey Peninsula Foundation, Pebble Beach Company, Northern California Golf Association, or the AT&T Company on account of injury or damages resulting from my participating as a volunteer.
